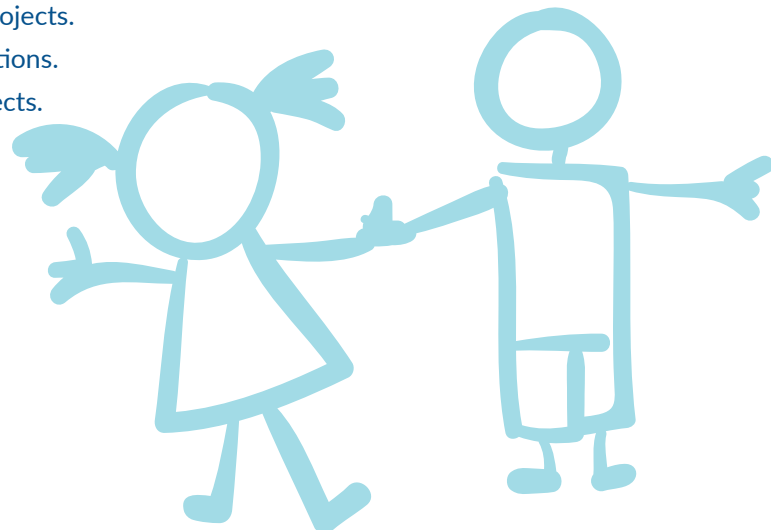

A healthy mind in a healthy body

Founded in 2017, Fondation d'Augustin (here in after referred to as "the Foundation") is an Ivorian philanthropic organization whose motto is: "A healthy mind in a healthy body". Through its actions for the benefit of Youth, the Foundation aims at contributing to the construction of a civic and responsible Cote d'Ivoire. We believe that Education and Health provide equal opportunities for all, and a more equitable society for all.

The first 16 months of our Foundation's life were busy both with activities and lessons learned.

The overall strategy of Fondation d'Augustin is based on **three main areas** :

The philosophy of Fondation d'Augustin is to have an impact on as many children as possible through construction or rehabilitation of School, Health, Sports or Food infrastructure. Our strategy consists in constructing infrastructure, coupled with support, accompaniment, monitoring and evaluation program for the sustainability and empowerment of infrastructure made available by the Foundation. Our endogenous monitoring system helps schools and health facilities ensure the long-term maintenance of their equipment and the supply of school canteens. The strategy for funding the Foundation's actions is based on two main methods:

- *Direct fundraising from potential sponsors / partners; ;*
- *Partnerships with other donors, foundations, NGOs, etc., to implement joint projects.*

In order to execute this strategy approved by the Board of Directors, the Foundation designs and implements three types of projects: (i) infrastructure projects, such as construction of primary schools or canteens; (ii) sustainability projects, which promote the empowerment or maintenance of infrastructure; and finally, (iii) support projects that can be carried out in parallel with our infrastructure projects or elsewhere, and consist of one-off assistance, such as the distribution of school kits or Christmas gifts for disadvantaged children

or the provision of medicines or any other form of assistance. We are convinced that this approach ensures better sustainability of our actions, and therefore an efficient use of the resources available to us.

Thus, upon and during design and identification of an infrastructure project, a community expert is mandated on site to raise awareness among and prepare beneficiaries to take ownership of the project and take all necessary actions upstream and downstream so that the said project be self-sufficient and sustainable, in conjunction with government action or not. For example, for the construction of a school canteen, the Foundation will ensure that this canteen operates as a community unit, where the whole community contributes in kind and / or in cash so that the children enrolled can have their meals.

At the end of sixteen months of operation, the greatest lesson learned, in order to guarantee the success of our actions, is the importance of the beneficiary community's involvement from the embryonic stage of the project implementation process. It is only in this context that projects can be developed in a viable way and be sustainable until the end of the Foundation's interventions.

These first months of our Foundation's life have enabled us to reach thousands of homes, individuals and children. We raised CFA F 240,150,490 of resources. In a nutshell, Fondation d'Augustin has implemented sixteen months of



infrastructure projects, including the construction of nine classrooms, two offices of director, two storage stores, 16 latrines and one school canteen with a capacity of 200 places and two sets of multiple systems of handwashing basins. It has also distributed 2,283 Christmas gifts, 4,562 school kits, 1,106 textbooks, 2,322 books, two air conditioning systems, three computers, three printers, 36 shelves for a school library, 140 school bags, 150 copybooks, 18 chalk boxes and three sports balls, 100 cataract surgery performed in partnership with a sister Foundation, four solar kits, including two for night literacy and two for lighting teachers' homes, 28 boxes of medicines, 160 kg of formula milk, 780 kg of rice and 220 Liters of oil.

washing devices, 2 series of hand-washing taps. Finally, it has conducted 24 mobilization and community organization missions, including 1 mission to raise awareness on hygiene and cleanliness.

Fondation d'Augustin has sixteen months of pride in hard work, perseverance and creativity to achieve remarkable results with very few resources. What drives us is the greatness and beauty of volunteering. It is altruism of individuals, corporations and sister foundations that fund our projects. Finally, we have a rigorous project reporting policy that reassures our donors about the use of the funds allocated to us, and which allows us to renew these donations and to manage our funds seriously and effectively.

Implementing social projects in the areas of Education and Health in Côte d'Ivoire is at the core of the mission of Fondation d'Augustin. To that end, the Foundation must raise funds or receive donations in kind. Since we began our activities in September 2017, we have constantly sought resources which have helped us implement all our projects.

Although newly created, the Foundation has succeeded in raising resources from both individuals and institutions. This is a sign of trust in its ability to deliver its mission through the implementation of its projects.

The next two paragraphs list the main donors of the Foundation as well as the main donations made to the Foundation over the last sixteen months.

In the 2017-2018 fiscal year, raising resources was carried out as follows:



1.1.

Donations in cash

Donations in cash - During the previous fiscal year, the Foundation raised a total amount of CFA F 229,852,780. The main donors are as follows:

- The Foundation for Equal Opportunities in Africa donated CFA F 98 million for the construction of a complete primary school in the village of N'gattakro;
- The Playhouse Foundation donated CFA F 28 million for the construction of a three-classroom school in the village of Djédouabo;
- Philipp Morris International provided CFA F 30 million grant for the construction of a three-classroom primary school in the city of Sinfra;
- Itraci and Nexans-CI contributed an amount of CFA F 5 million to our fundraising effort;
- Two financial institutions, namely BICICI and BACI, donated CFA F 4 million in contribution to a project of Lycée Moderne de Dimbokro (Dimbokro high school)
- The Dangote's Foundation donated 34 million of CFA for sports field restoration, the construction of a cloakroom, a teacher's office, a storage room, latrines and hand-washing basins for staff at Lycée Moderne de Dimbokro.

Donations to the Foundation in kind

In-kind Donations - Received from companies and individuals, these donations have contributed to supporting our infrastructure projects as well as specific actions. We estimate their value at nearly CFA F 20 million. We can mention among others:

- The construction of the 8 latrines of the Ecole primaire publique (EPP) of the Djédouabo project;
- The provision of equipment, as well as cleaning and maintenance material (garbage pails, brooms, detergent, etc.), from the National Agency for Waste Management (ANAGED) and Mr. P. Zarka;
- The donation, by Mr. A. Bassit and Hôpital Dieu, of a batch of essential medicines which were then given to the Rural Education Center and to the Illomba health clinic;
- Nearly 780 kg of rice and oil by Mr. C. Nkontchou, Mr. L. M'Bahia Blé, SIFCA and Mr. B. Kouamé;
- Three desktop computers and two printers by Mr. D. Nzi, Mr. K. Ndri and Éditions Eburnie.
- Two air conditioners by Mr. D. Nzi and Ms. E. Nkontchou;
- 4,000 books collected by a secondary school student, volunteer of the Foundation;
- 3,000 bags of school kits and Christmas gifts by Mr. Fakrih, as well as by Multipack and Vit'imprim International;
- Christmas gift vouchers provided by the company Tullow, with a value of CFA F 2,025,000;
- Two school kits of a value of CFA F 1,000,000, by the company ZECl.

2. Our Infrastructure and Sustainability Projects

In the 2017-2018 fiscal year, our efforts focused on three infrastructure and sustainability projects for:

1. The Ecole Primaire Publique (E.P.P.–public primary school) of N’Gattakro;
2. The Ecole Primaire Publique (E.P.P.– public primary school) of Djédouabo;
3. The Lycée moderne of Dimbokro (Dimbokro High School)

2.1.1 Infrastructure Construction

The project consisted in constructing two new buildings to replace two old ones built in 1976, which were in a very advanced state of disrepair. This project is fully in line with the Foundation's two strategic thrusts, namely:

Education - the new school buildings have provided students with adequate infrastructure, thus improving their educational environment;

Health - in addition to the two school buildings, a canteen, latrines and hand-washing basins have been built to help improve students' health through better nutrition and hygiene.

The implementation of this project in its entirety has helped improve the living, hygiene and educational conditions of the students of the village of N'gattakro and the surrounding camps within a radius of more than five kilometers thanks to its secure and healthier infrastructure. In addition, the construction of the canteen allowed for community catering and contributed to better attendance as well as a significant reduction of students' physical fatigue.

2017-2018 has seen about a 10% increase of the overall school enrollment. Therefore, we can project that in the next 10 years, this project will have positively affected more than 7,200 children.





2.1.2 Sustainability

One of the Foundation's strategic objectives is to ensure the sustainability and maintenance of the infrastructure provided to beneficiary communities as part of the projects implemented. In order to achieve this objective, a community mobilization expert was mandated on site, at several stages of the project, in order to establish community development mechanisms for sustainability of the project as a whole. The community groups (youth association, women's association, managers and nationals association, and students' association) have facilitated the organization of a community canteen and sensitization of the educational community on maintenance of the school environment.



Observations

N'Gattakro's main challenge remains the difficulty of mobilizing the whole of its village community



2.1.2.1 Sustainability of the school canteen

Thanks to the specific interventions of our community mobilizer, the canteen was able to serve the 630 students of the Groupe Scolaire for 6 months at minimal cost. Today, as part of the national school canteen program, the N'Gattakro school canteen manages to provide all its students with shifts per day with a contribution of CFA F 25 per student paid by the parents. The community canteen management system established in N'Gattakro has so far produced positive and encouraging results.

2.1.2.2 Community Mobilization

Our community mobilization expert, who still intervenes in the community of N'Gattakro, has undergone the following:

- Performed a community diagnostic;
- Implemented community development mechanisms (Youth Association, Women Association, Managers Association, Alumni and Students Association, etc.);
- Implemented a community-run canteen for the 630 pupils at N'Gattakro
- Two training sessions on planification and resource mobilization techniques;
- Sensibilization training to the maintenance and upkeep of the school environment.

2.1.2.3 Awareness-raising Campaign on Hygiene at EPP N'Gattakro

With the support of the Ministry of Health and Public Hygiene, and through the Direction for Public Hygiene and Health Environment, our Foundation organized awareness-raising sessions on Hygiene at the primary school of N'Gattakro. These sessions targeted teachers, students and canteen staff. The twofold objective was to train the school population on good health habits and to teach students how to make soap and how to use it for better personal hygiene and for washing the dishes in the canteen.

2.1.2.4 Donation of ingredients for making traditional soap for EPP N'Gattakro

Our Foundation donated ingredients to the school canteen of EPP N'Gattakro for making handcrafted soap. This donation is part of the school sustainability project. Indeed, ingredients for making traditional soap contributed to the start of the project, which in the long run will empower the supply of detergent for the needs of the canteen and students.

2.1.2.5 Donation of hygiene and sanitation materials and equipment

Fondation d'Augustin collaborated with the government agency in charge of sanitation (Agence Nationale de Gestion des Déchets, ANAGED) to donate sanitation equipment and materials, including cleaning products. The materials and equipment received were delivered to the school to encourage the good maintenance, cleanliness and sanitation of the premises.

I arrived in this school in September 2008. I found a school in a state of disrepair. This situation was a threat to students' and teachers' lives. From that time, we had not stopped knocking on the doors of the relevant authorities in order to find a solution but nothing helped. It was during a visit of the sub-prefect of Daoukro to N'gattakro, during the discussions with teachers, that we invited him to visit our temple of knowledge (school) to appreciate the state of disrepair and the risk it represented for everyone working there every day. After his visit, he commented, «I do not want to be accountable for the death of a student or teacher in my area. For this reason, I will do anything to change the situation.» »

That was the beginning of the partnership between Fondation d'Augustin and our school : less than a month later, we received the visit of Madame Tanoh, President of Fondation d'Augustin, who came with a strong delegation. Following a guided tour, Madame Tanoh committed to destroy the two old buildings and rebuild them in a short time.

Against all the odds, she built a school canteen and latrines. She put her words into deeds and the result was excellent. Thanks to Fondation d'Augustin and its donors, EPP N'gattakro is among the most beautiful primary schools in the region of IFFOU.

Thanks to the school canteen, the attendance rate has increased from 75% to 99% since the inauguration of the new building. The number of students in CP1 continues to increase each year, by an average of 40 students to 70 students

The quality of the standards of the school and the regularity of the meals in the school canteen have contributed to the improvement of school performance. With an average of 64%, the success rate has risen to 79% since last year. Absences without reasonable excuse have completely disappeared since this school year, leaving room for cases of illness and even in some instances students refusing to go home despite being ill and waiting to eat before leaving.

I would like to take the opportunity to pay a heartfelt tribute to Fondation d'Augustin and all its donors for this act of generosity towards the children of COTE D'IVOIRE and in particular to the locality of N'GATTAKRO. We extend our gratitude to Mr. and Mrs. THIERRY TANOHO who by their humanism have allowed the realization of this project. May GOD repay you one hundredfold for this good cause.

2.2 EPP Djédouabo

Djédouabo is a village of 900 inhabitants without access to electricity, and whose access to drinking water is provided through a mechanical pump. The village has a public primary school with six classrooms (from CP1 to CM2) and 122 students (76 girls and 46 boys). This school was built from precarious materials (mainly clay bricks.) The small number of students of this primary school was due to the precarious nature of its infrastructure, which drove the inhabitants of the village and surrounding encampments to send their children, in the best case, to the village of Angouakro (2,500 inhabitants) located 11 km away or, in the worst case, to other cities in Côte d'Ivoire, where children were then given to guardians in order to be educated in safer schools built with sustainable materials.





2.2.1.

Infrastructure Construction in Djédouabo

This project consisted in constructing a new 3-classroom building for Djédouabo primary school to replace classrooms built using precarious materials.

This Project is directly in line with the Foundation's two strategic thrusts, namely:

Education - the new school buildings have allowed students to work in a healthy, adequate and safer environment, thus improving their education conditions;

Health - in addition to the school building, latrines were built to improve hygiene conditions and therefore children's health. This project, in its entirety, has helped improve the quality of life of students in the village of Djédouabo and the surrounding camps (within a radius of more than five kilometers) by providing them with safe and healthy school facilities. We estimate that this project will impact the lives of 1,300 students over the next 10 years.

2.2.2.

Sustainability





2.2.2.1. Solar Energy

Fondation d'Augustin, in partnership with the company ZECI, has equipped the village of Djédouabo with four independent solar energy panels. Two solar kits for the newly-built school will allow night time literacy for the village adult population. Two others for the two teachers' housing units will power the lamps, fans and televisions supplied.

2.2.2.2. Community Mobilization

- Our community mobilization expert performed the following tasks in Djédouabo:
- Conducted the community participatory diagnosis;
- Set up community development mechanisms (youth association, women's association, managers association, students' association);
- Helped create the Djédouabo development membership organization;
- Mobilized the educational community to create a yam farm for the school;
- Mobilized the community for active participation in school construction works;
- Mobilized women to create a community cassava field to support the school canteen
- Organized two training sessions on planning and resource mobilization techniques.

2.2.2.3. Donation of hygiene and sanitation materials and equipment to EPP Djédouabo

Fondation d'Augustin, in partnership with the government agency in charge of Sanitation (Agence Nationale de Gestion des Déchets, ANAGED) donated sanitation equipment, materials and cleaning products. These donations aim at encouraging good maintenance and cleanliness of the premises.

2.2.2.4 Way Forward

- In order to improve the chances of sustaining the infrastructure provided to the Djédouabo community, the interventions of our community mobilizer will continue for another few months, as well as some interventions with our various partners, including:
- Organization of literacy courses for the Djédouabo community;
- Community mobilization for the creation of a community henhouse;
- Awareness-raising campaign on hygiene for students and teachers.

E.P.P Djedouabo is part of the inspection of the preschool and primary education of Ouélé. The school is located in the educational sector of Ananda under the Regional Directorate of the National Education, Technical and Vocational Training of Daoukro.

Djedouabo primary school has six teachers from CP1 to CM2. The old school was comprised of buildings made up of clay and straw, without toilets and lighting. However, since 14th November 2018, the school has benefited from a new three-classroom building, a director's office and a storage room. In addition, the school now has modern toilets and solar lights (ZOLA company) all donated by Fondation d'Augustin. At the official delivery of the building, Fondation d'Augustin donated solar light kits, a handwashing basin, classroom bins, a metal bin for the school yard and school bags for all students.

Teachers used to live in the dark. They now benefit from solar light installation (ZOLA company) in their homes. All these actions done for the benefits of students and teachers of E.P.P Djedouabo, have led parents to regain trust in the teaching carried out in this small village. Parents have brought back their children who were in the regions of San Pedro and Soubre. In addition to sanitary facilities and toilets, students' behaviour has improved. Support classes are also organized in the evenings thanks to light in the classrooms. For teachers, this equipment makes it possible to overcome darkness, to work at night, to access information, to entertain themselves with TV or listen to the radio. It is important to note that Djedouabo and the surrounding villages can feel the considerable impact of the actions undertaken for the students of this school.

Lycée Moderne of Dimbokro (LMD)

Officially opened in November 1966, the Lycée Moderne de Dimbokro (LMD) is a co-educational public secondary school with two cycles, from 6ème to terminale. It is built on a 22-hectare site and consists of 58 buildings, including 18 former dormitories converted into classrooms. All these buildings house 68 rooms, 4 laboratories and 4 collection rooms. This school caters for over 5,100 students. It is at the LMD that the late Mr. Augustin Tanoh, whose first name has been given to the Foundation, was last appointed, becoming the first Ivorian PRINCIPAL to be appointed to this position in this school.

The project comprises two folds: (i) rehabilitating and equipping the library, and (ii) building a locker room for 40 students, a satellite office for teachers, and a storage room for sports equipment, the rehabilitation of sports courts for the practice of basketball, volleyball and handball in addition to the construction of latrines and waterpoints for the children.

This project proposed by Fondation d'Augustin is directly in line with its two strategic thrusts:

Education - sport is a tool for teaching essential social and community values, such as sharing, discipline, respect, fair play, perseverance and social cohesion. The construction of the five sports courts will provide better sports facilities likely to improve the quality of education and health of the students. The refurbishing of the LMD library and the provision of books to enrich its collection, as well as the supply of computer equipment and air conditioning, will help provide the entire school community with a healthy, pleasant and well-equipped environment for access to culture through reading, study and research.

The library's air conditioning, in an environment where temperatures can reach up to 37 degrees Celsius, will provide the minimum comfort needed. In addition, the expansion of the windows will provide more light to the library for better visual comfort for students.

Health - the health benefits of sport are numerous and widely recognised. These include: reduction of stress, awakening of the senses, strengthening of concentration, improved cardiovascular, neuromuscular

and locomotor development, as well as maintaining a good weight balance. Such benefits are also conducive to a better understanding of lessons by the students.

In its entirety, this project will contribute not only to the development of students, but also to the improvement of the basic infrastructure of the Lycée Moderne of Dimbokro. Over the next 10 years, 55,000 students will be positively impacted by the implementation of this project of the Foundation.

2.3.1.

Infrastructure construction

2.3.1.1 Refurbishing of the library of the Lycée Moderne of Dimbokro (LMD)

This component of the project is being implemented in collaboration with the SMC (School Management Committee) of the LMD and the Service de la Promotion de la Lecture et des Bibliothèques Scolaires or SPLBS (Service for the Promotion of Reading and School Libraries). The Foundation is providing and installing air conditioning equipment, two computers and printers to monitor the documentation inventory, solid wooden shelves, furniture for the comfort of students, lighting, as well as about 2,000 books and magazines collected as part of a sub-project initiated by a 15 year-old high school student, a volunteer from our Foundation. As for the SMC, it is rehabilitating the library building, which includes waterproofing, flooring, and painting. The role of the SPLBS is to train the librarian in books storage and categorization.

2.3.1.2 Construction of the sports courts of the Lycée Moderne of Dimbokro (LMD)

This second component of the project, which will benefit all the 5,000 students of the LMD, includes the construction of a basic locker room (girls / boys; non-existing to date) with a capacity of 40 students, a storage room for sports equipment, an office for physical and





sports education (PES) teachers, the purchase of specialized equipment (nets, balls, jerseys, etc.), and the refurbishing of five courts dedicated to football, basketball, volleyball and handball, including installation of metal poles.

2.3.2.

Community Mobilization

Our community expert carried out the following tasks:

Community diagnosis for the educational community of the Lycée Moderne de Dimbokro;

- Working sessions with all key stakeholders (municipality, regional council, parents, students and members of the administration);
- Establishment of a committee to monitor the project;
- Development of an action plan for maintaining cleanliness within the Lycée Moderne of Dimbokro.

3. Our Support Actions

In the 2017-2018 fiscal year, our support actions were implemented around nine projects. Some of them were carried out in the continuity of projects already implemented by the Foundation, others were punctual actions. In the latter case, the Foundation's choice was made by taking into account the good reputation of the organizations supported. These actions were made possible largely thanks to donations in kind from individuals or companies as described in Chapter 1.2.

School kits for all

A donation of a total of 500 Kg of rice and 100L of cooking oil was made to the N'Gattakro school canteen to support the preparation and diversification of meals.

Last school year (2017-2018,) the Foundation distributed 1,914 school kits and 900 teaching materials. For this school year (2018-2019), our objective to distribute 3,000 school kits has been largely achieved. In the end, we purchased a total of 3,118 kits and 232 teaching materials (a 63 % increase in the number of school kits compared to the first year) as follows:

- 14 schools in the Iffou region received 1,868 kits and 152 teaching materials including text books;
- 600 kits and 41 textbooks were distributed in the Hambol region;
- 180 kits and 13 textbooks were delivered to two private schools in disadvantaged neighborhoods in the Abidjan region.

This support action has reached more than 3,000 families.



3.3.

Christmas for All

As part of the “Christmas for All” operation, Fondation d’Augustin has financially contributed to the preparation of 648 meals for children in six villages. Eight Christmas celebrations were organized during this period, as well as seven visits to pediatric hospital centers throughout the country. These events were all enhanced by the presence of our own Santa Claus. In 2017, 632 toys were distributed in the Iffou region to the children of E.P.P N’gattakro, as part of the Christmas celebration. In 2018, there was a considerable increase in this figure; the Foundation donated 651 toys bought from its own funds and another 1,000 toys were financed by an international donor. To date, 221 toys have been distributed at E.P.P Dangou, 150 toys at E.P.P Djédouabo, 42 toys in the pediatric centers of Dimbokro regional hospitals, 62 toys in Korhogo, Bouaké and Yamoussoukro, 41 toys at Treichville University Hospital, 86 toys at Yopougou University Hospital, 300 toys for the benefit of children targeted by the Ministry of Solidarity, Family, Women and Children (orphans, abandoned, deprived and disabled). In total, approximately 2,200 children were reached by this action.

3.4.1. Donation of 57 books and one computer to the Centre de Formation Sainte Thérèse de l'Enfant Jésus

The Centre de formation Sainte Thérèse de l'Enfant Jésus, located in Port-Bouët, in a precarious neighborhood called Adjoufou, is dedicated to literacy and apprenticeship for disadvantaged girls and women, in training to become seamstresses, pastry cooks and hairdressers. On March 8, 2018, International Women's Day, our Foundation donated 57 books and a desktop computer to the library of the cultural enrichment and for computer learning. This material will promote learning for the young women of the center, and will also benefit the children of the neighborhood for whom the center's library is accessible.

3.4.2. Empowering the Girl Child in Africa

This project, which consists in creating a documentary, was launched early February 2018 and implemented in partnership with the Sahara Foundation (with which our Foundation also implemented the "Campaign for cataract screening and care project in the municipality of Daoukro" in December 2017). The objective of this project was to highlight the challenges faced by every young African girl through video testimonies and other information technology tools with the participation of Ms. Zuriel Oduwole, a young American activist for the rights of young women, who was accompanied by her younger

sister. The final film production, which will include elements from Nigeria, Ghana and Côte d'Ivoire, will be presented in New York before the Secretary General of the United Nations.

3.5.

Centre de Santé Pietro Bonilli in Odienné (Pietro Bonilli Health Center)

On February 16, 2018, as part of its program to "control and prevent malnutrition among young children within a therapeutic nutritional unit and with follow-up activities for children born to mothers living with HIV", Fondation d'Augustin donated 160 kg of infant formula and milk, which is the equivalent of a full year of milk supply, to the Pietro Bonilli Health Centre of Odienné.





3.6.

Participation to the cataract screening and surgeries in Daoukro, in collaboration with the Sahara International Foundation and the NGO Light First.

In collaboration with the Sahara International Foundation, Fondation d'Augustin provided all the administrative and logistical support that made possible a screening campaign and of 100 free cataract surgeries in the Daoukro prefecture.

3.7.

3.7. Participation in “Les cantines du Cœur”, a project initiated by the NGO Ivoire Développement Durable.

In order to diversify the supply for public school canteens throughout Côte d'Ivoire, the NGO Ivoire Développement Durable (“ONG Ivoire DD”) organizes each year a fundraising operation aimed at individuals, associations and private sector companies. This operation is called “Les Cantines du Cœur” and consists in distributing meals to students in public schools throughout the country. For its 2nd participation to “Les Cantines du Cœur”, on March 21, 2018, Fondation d'Augustin made a donation of CFAF 500,000 which contributed to acquire 1,428 meals for public sector students.

4.1.

Lycée Moderne of Dimbokro (LMD)

Upon completion and inauguration of the new library of the LMD, scheduled for April 2019, the construction work of the locker room and sports courts will resume. The delivery of this infrastructure will be coupled with the delivery of sports equipment and other material (balls, jerseys, timing devices, etc.). The second phase should be completed by the end of the 2019 school year.



4.2.

Groupe Scolaire of Djamandji, SINFRA

The school complex of the city of Djamandji (15,000 inhabitants), located in the commune of Sinfra, Marahoué Region, has 20 classrooms, from CP1 to CM2, and a total enrollment of 1,324 students (581 girls and 743 boys). The dilapidated premises and the disproportionate number of students, the lack of latrines, the lack of drinking water, the lack of electricity, and the lack of benches are factors that impact the quality of the education provided in this primary school, which has an average of 66 students per classroom. In addition to these difficult learning and teaching conditions, the condition of the buildings (roofs, floors, walls, etc.) is a constant risk to the health and safety of students and teachers.

Following a request for funding made to a multinational group, the Foundation received a donation that will be used to build a new 3-classroom building with four latrines at EPP Djamandji.

At the onset of the project, our community organizer was mandated on site to undertake the work of preparing the entire community to adopt and take ownership of the project.

4.3.

Literacy Program in Djédouabo

This project is supported by the Foundation and its community organizer. It will be made possible thanks to solar electrification provided by the foundation, which will allow night literacy classes.

4.4.

School Entrepreneurship Project Chicken Farming - in partnership with Direction of school life

This project will be made possible thanks to some financial support from the Foundation in partnership with the Direction of school life the Ministry of National Education, and possibly with a local chick supply company. This type of project could allow the school to generate the funds that will allow it to sustain its infrastructure and provide for its needs autonomously.



4.5.

One school, 5 ha of forest” project, in partnership with the Ministry of Water and Forests

The reforestation project “one school, 5 ha of forest” is an initiative of the Ministry of Water and Forests. Implemented in collaboration with the Ministry of National Education and Technical Training, it aims at imparting knowledge, know-how and soft skills about forests to children and making them environmentally aware citizens. This project will also help maintain school infrastructure by providing the possibility to get income from the sale of trees and allows women to cultivate food crops or market garden produce, the surplus of which may be donated to the school and the women associations.

4.6.

Centre de Santé Pietro Bonilli of Odienné (Pietro Bonilli Health Center)

For the second consecutive time, a donation of 235 kg of infant formula (one year of milk supply) will be made to the Pietro Bonilli Health Center of Odienné, as part of their program to “control and prevent malnutrition among young children within a therapeutic nutritional unit and follow-up activities for the children born to mothers living with HIV”.



CONCLUSION

The Positive Impact

In sixteen months of action, Fondation d'Augustin has positively impacted the lives of more than 7,500 children, by:

- Rebuilding the public primary schools of N'gattakro and Djédouabo,
- Completing the construction of the library and sports courts of the Lycée Moderne of Dimbroko,
- Distributing school kits and Christmas gifts,

Thanks to the N'gattakro canteen, 630 children can eat on site, avoiding excessive fatigue, accidents and the risk of school drop out. Thanks to the new school in Djédouabo, a little girl (among several other children) who was attending school by staying with relatives in Daloa (nearly 300 km away) was able to return home. Thanks to the various "Christmas for all" editions, many children received a Christmas gift for the first time and met with Santa Claus. Thanks to our participation in the « Cantines du Cœur », 1,428 children received one hot and complete meal in their school canteen. Finally, thanks to the donation of 160 kg of infant formula, children orphaned by AIDS were able to be fed for a whole year, and 15 of them were saved from almost certain death.

Nearly 10,000 children and vulnerable individuals in Côte d'Ivoire have been positively impacted by the actions Fondation d'Augustin. We welcome this new year of projects with a lot of energy and with the hope to be able to pursue our work thanks to the continued support of the Friends and Donors of Fondation d'Augustin.

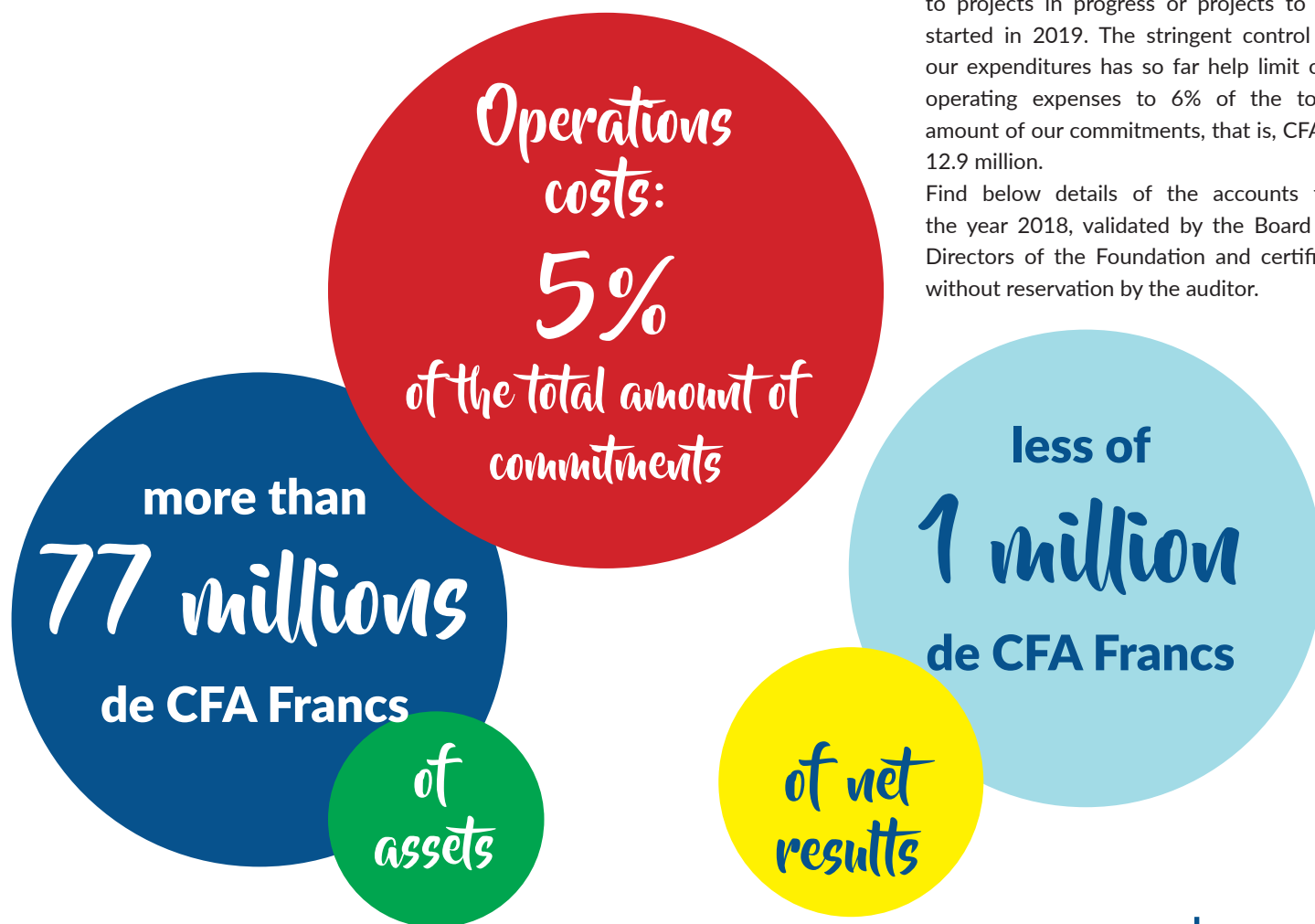

FINANCIAL REPORT



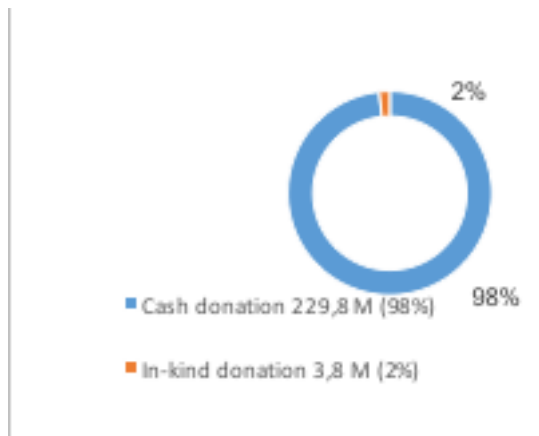
With association funds without takeover rights of CFA F 10 million, the first accounting year of Fondation d'Augustin recorded several achievements. In 16 months of activities, CFA F 233 million has been raised. More than USD 159.9 million has been incurred for our infrastructure, sustainability and support projects.

CFA F 64.2 million represents funds mobilized or to be mobilized dedicated to projects in progress or projects to be started in 2019. The stringent control of our expenditures has so far help limit our operating expenses to 6% of the total amount of our commitments, that is, CFA F 12.9 million.

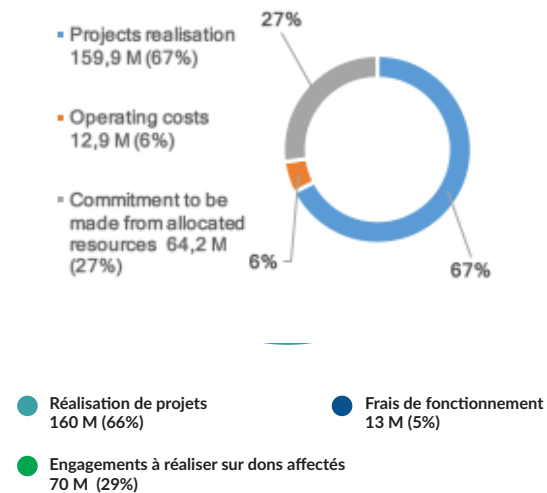

RESOURCE UTILIZATION



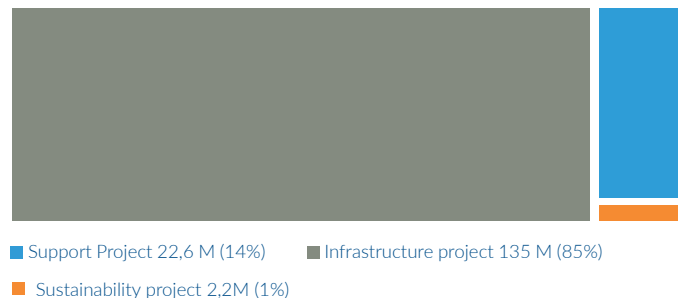
Resource Mobilization

The financial resources mobilized by Fondation d'Augustin from institutions (international and local), and from individuals are composed of 98% cash, that is, CFA F 229.2 million and collection bonds representing 2%, that is, CFA F 3.8 million.

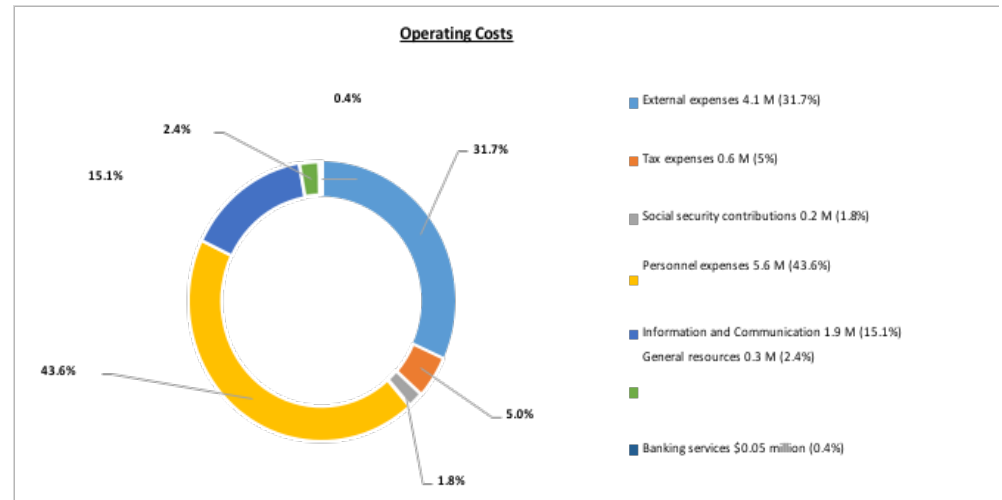

In 16 months of activity, operating costs represent 6% of the Foundation's total expenses, that is, CFA F 12,953,556. They include the following:



3. 3. Carry-forward of non-utilized resources from previous fiscal years

CFA F 34,133,172 are planned for finalization of our two projects of the Lycée Moderne de Dimbokro: the project to rehabilitate the sports field (33,133,172) and the project to build the Documentation and Information Centre, CDI (1,000,000).

CFA F 30,082,984 will be used to build a new 3-classroom building and latrines for the Djamandji village educational community in early 2019.



1. Presentation of annual accounts

- The 2017-2018 annual accounts of Fondation d'Augustin describes its activities, results and assets through its mission of general interest, which is to contribute to the social development of Ivorian youth through implementation of education and / or-related health projects.
- The Foundation's accounts include:
- the balance sheet, which describes the historical and current value of the assets and liabilities of all the elements managed by the Foundation;
- the income statement, presented by functions, which summarizes and compiles the income and expenditures of the fiscal year according to their purpose;
- the cash flow statement, which describes the Foundation's cash transactions (receipts and disbursements performed or to be performed).

1. Accounting Rules & Methods

- The financial statements have been prepared in accordance with the Uniform Act on Accounting Law and Financial Information and the Revised OHADA Accounting System (SYSCOHADA), which is the Common Accounting Law.
- In the absence of specific provisions relating to Associations contained in

this Uniform Act and the SYSCOHADA, the Foundation uses the specific accounting rules developed for the associative sector in France. The rules applied by the Foundation are presented below. The format of the financial statements has been modified accordingly.

- The financial statements have been prepared on a going concern basis, in accordance with the assumptions, policies and valuation rules set out in the Uniform Act on Accounting and Information Law and the revised SYSCOHADA accounting system annexed thereto. (Prudence - transparency - materiality - inviolability of the balance sheet - historical cost - going concern - consistency of methods - specialization of financial years).
- The Foundation is in its first year, which lasted 16 months. The accounting rules and methods applied are presented below.

i. Tangible Assets

Tangible fixed assets are valued and recorded at their acquisition costs. Depreciation is calculated on a straight-line basis over the estimated useful life of the various categories of fixed assets. Computer equipment is depreciated at the rate of 50%, office equipment and furniture at the rate of 20%.

ii. Equity: Association funds without takeover rights

Associative funds without takeover rights constitute funds that cannot be taken over by the members of the association. They indicate the definitive provision of a property for the benefit of the association. The initial endowment made by the members is in the nature of a contribution without transfer duty and forms an integral part of the association's funds.

The foundation's statutes provide for an initial donation of CFA F 10,000,000. It was fully paid up as at 31 December 2018.

iii. Other association funds:

Association funds with takeover rights constitute contributions from members - funds that can be taken over under the conditions provided for in the contribution agreement. They involve the temporary provision of property for the benefit of the association. In addition to the entry in association funds, the association must ensure that it translates into accounting the charges and provisions enabling it to fulfill its obligations towards the contributor.

iv. Dedicated funds

At the end of the financial year, dedicated funds record the part of resources allocated by third party funders to defined projects that have not yet been used in accordance with the commitment made to them.

This account is credited by debiting the expense account «Commitment to be made from allocated resources» in order to acknowledge the commitment made by the association to continue the implementation of the said projects. This account is debited by crediting the income account «Carryover of unused resources from previous years» during the year in which the commitment is made. Dedicated funds may not be used for any purpose other than that agreed.

v. Donations and Legacies

Gifts and legacies by authentic instruments should be distinguished from manual donations, operations consisting of the free delivery of tangible movable property.

Manual donations are revenue of the year. Manual donations allocated (to projects) are treated at year-end as dedicated funds. Unrestricted manual donations remain recorded as income for the year.

Manual donations are recognized as revenue when received or pledged. Commitments to contribute are recorded as income against a receivable if the amount to be received can be reasonably estimated and its receipt is reasonably assured.

YEAR ENDED DECEMBER 31, 2018

Opinion

We have audited the annual financial statements of La Fondation d'Augustin, including the balance sheet as at 31 December 2018, the income statement, the cash flow statement for the year then ended and the notes thereto.

In our opinion, the attached annual financial statements are regular and fair and give a true and fair view of the results of operations for the past financial year and of the financial situation and assets of the Foundation at the end of that financial year in accordance with the accounting rules and methods laid down by the OHADA Uniform Act on Accounting Law and Financial Reporting.

Basis of opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs), adopted by the provisions of Regulation No. 01/2017/CM/OHADA on the harmonization of the practices of accounting and auditing professionals. independence of the statutory auditor. We have met our other ethical responsibilities under these rules. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of the Executive Board regarding the annual financial statements

The annual financial statements have been prepared and approved by the Executive Board.

The Executive Board is responsible for the preparation and fair presentation of the annual financial statements in accordance with the accounting rules and methods published by the OHADA Uniform Act on Accounting Law and Financial Reporting, and for such internal control as it considers necessary to enable the preparation of annual financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the annual financial statements, the Executive Board is responsible for assessing the Foundation's ability to continue as a going concern, for providing going concern information, if any, and for applying the going concern accounting policy, unless the Executive Board intends to wind up or cease operations or if there is no other realistic alternative available to it. The Executive Board is responsible for overseeing the Foundation's financial reporting process.


Responsibilities of the auditor in relation to the audit of the annual financial statements
